### **The character of criminal States and governments**

AMERICA, The world's leading civilian killing nation, recently took the (fateful) plunge into pure sociopathology by attempting to use a crime as an argument to justify the crime itself! A watershed moment in the continuing decline and (now certain) future collapse of the USA has occurred!

EXPOSED offenders were once tried and punished according to the measure of their crimes -- I need not remind AMERICANS that TORTURE, which is NOW tolerated in the USA, continues to be regarded by the CIVILISED WORLD as a particularly heinous and brutal crime against HUMANITY!

CIA chief, Leon Panetta, and other high ranking officials in the Obama administration, are making formal objection to the release of incriminating video information detailing torture on the grounds that it would prejudice the standing of the USA in the international community and that it would supply those in favour of prosecution with the evidence required to bring the CULPABLE to TRIAL! Well of course, but let's not forget that horrific crimes against humanity would be curtailed and the culpable would be held accountable -- allow the LAW to do its job, THAT'S HOW OPEN, HEALTHY DEMOCRACIES SELF-REGULATE!
