

Paltry Payout for Gross Injustice

A deaf mute man (soft target) **WRONGLY** convicted of a murder by an incompetent and grossly biased West Australian legal system has been awarded less than half a million dollars for his fifteen (15) year wrongful imprisonment.

Darryl Beamish, victim of the State, was initially sentenced to **DEATH**; how very fortunate for all concerned that the sentence was commuted to **LIFE** imprisonment, which allowed time to reveal the **TRUTH** of the crime.

The token ex-gratia payment of less than half a million dollars offered to a socially handicapped man, hardly compensates for the psychological torture, grief and extreme hardship this man suffered at the hands of the State! The amount offered by the State merely adds insult to injury.

We are reminded of other **GROSS** legal injustices at the Hague, a court that also chases soft targets and completely ignores the civilian killing **HOLOCAUST CRIMES** of powerful Western States. Compo for man wrongly jailed for 15 years

A Western Australian man has been awarded a \$425,000 ex-gratia payment after he spent 15 years in jail for a murder he did not commit.

Darryl Beamish, who is deaf and cannot speak, was convicted of murdering socialite heiress Jillian Brewer in her Cottesloe unit in 1959.

She was attacked with a tomahawk and a pair of scissors.

Mr Beamish was convicted of wilful murder and sentenced to death, which was commuted to life imprisonment because of his disability.

Despite a later confession to the murder by Perth serial killer Eric Edgar Cook, Mr Beamish's conviction was upheld.

In 2005, after a lengthy campaign to clear his name, the Court of Appeal quashed his conviction on the basis that a "substantial miscarriage of justice" had occurred.

In a statement, the WA Attorney General Christian Porter said ex-gratia payments are not intended to fully compensate individuals for loss or detriment suffered.

"In this instance, the Government is satisfied that sufficiently extraordinary circumstances exist to justify an ex-gratia payment," he said.

"This payment is intended to express the State's sincerest regret for what occurred and provide him with a measure of comfort and financial security in his retirement."

The compensation payment follows other high-profile, wrongful imprisonment payments to West Australians Andrew Mallard and John Button.
