Julia Gillard slips up on carbon compo

JULIA Gillard has been forced to backpedal from a promise that seven million Australian households won't be worse off under Labor's carbon tax.

The Prime Minister today told ABC Television that “seven million Australian households won't see a cent lost through carbon pricing”.

But when asked about that pledge her office was quick to clarify.

A spokesman said that Ms Gillard meant to say that of the nine out of 10 households to receive assistance, the “vast majority” wouldn't be out of pocket.

In announcing the scope of the assistance on Sunday, Ms Gillard said “the vast majority we assist actually won't pay any price because of the assistance that they receive”.

Treasurer Wayne Swan yesterday refused to say how many of the seven million would be fully compensated via tax cuts or increased welfare payments.

Ms Gillard today also refused to rule out the possibility that the carbon price won't be announced in July, as promised.

The package - including household and business assistance - was originally meant to be released by the "beginning" of the month.

Now it will be made public as soon as possible.

"We're certainly aiming to get this done as soon as we can ... but we're going to get every bit of this [*un-mandated Penalty Tax*] right, [*for Goldman Sachs and Wall Street*]" Ms Gillard said.
