

US Executive may Veto Senate Bill on Indefinite Detention for 'Terrorist' Suspects

An Ongoing Political Farce

The Executive Office is 'now' seriously considering a Veto (for political reasons) on the recently passed indefinite detention provision in the Bill. It seems the provision would complicate 'legal' matters for the world's leading terrorist State:

"Detainee Matters: The Administration objects to and has serious legal and policy concerns about many of the detainee provisions in the bill. In their current form, some of these provisions disrupt the Executive branch's ability to enforce the law and impose unwise and unwarranted restrictions on the U.S. Government's ability to aggressively combat international terrorism; other provisions inject legal uncertainty and ambiguity that may only complicate the military's operations and detention practices...

The Administration strongly objects to the military custody provision of section 1032, which would appear to mandate military custody for a certain class of terrorism suspects. This unnecessary, untested, and legally controversial restriction of the President's authority to defend the Nation from terrorist threats would tie the hands of our intelligence and law enforcement professionals. Moreover, applying this military custody requirement to individuals inside the United States, as some Members of Congress have suggested is their intention, would raise serious and unsettled legal questions and would be inconsistent with the fundamental American principle that our military does not patrol our streets."

[The new provision would be in direct violation of the "Posse Comitatus Act" of 1878 which expressly forbids the US military undertaking any domestic policing role - nevertheless, the 1878 act is easily [circumvented](#) and has been used politically by various astute politicians.]

Posse Comitatus notwithstanding, the current Bill received overwhelming bi-partisan support in the Senate, which does reflect the current position of bought American politicians and the criminal Corporate powers that own them. So, in view of the initial presidential proposal of a 'thought crime' indefinite detention act, we could safely assume the public will see the provision, with some minor cosmetic variations, passed into law - the Corporate PNAC agenda has varied little since its original formulation.

Reference is constantly made by various American politicians and commentators to al-Qaeda and the 'suspected affiliated terrorists' referred to in the Bill, remember the right to arrest on 'suspicion' would be granted the authorities in this Bill.
